In consideration of ANB Soccer, Inc. allowing the Participant to participate in the Program, the Participant, individually, and on behalf of any heirs, personal representatives, assigns, family, next of kin, beneficiaries, agents, successors and assigns (Hereafter, collectively, "Participant") acknowledge and agree as follows:			
1.	Acknowledgement of Risk. Participant understands and acknowledges that the Program has inherent risks, hazards and dangers and that participation in the Program may results in ACCIDENT, ILLNESS, PHYSICAL INJURY, DEATH, PROPERTY DAMAGE, or other HARM or DAMAGE. Participant understands and acknowledges that there are inherent or unexpected risks and dangers associated both with the sport of soccer and also otherwise resulting from participation in the Program and the sport of soccer. Participant understands and acknowledges that there may be other risks and dangers involved in participation in the Program of which he or she may not be presently aware or which cannot be predicted or controlled.			
2.	Assumption of Risk and Responsibility. Notwithstanding and recognizing all of the risks, inherent or otherwise, associated with the Program, Participant HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF ACCIDENT, ILLNESS, PHYSICAL INJURY, DEATH, PROPERTY DAMAGE, and all HARM or DAMAGE (collectively "Injury"), whether known or unknown, arising out of or related to the Program(s) however caused even if caused by the NEGLIGENCE OR CARELESSNESS OF ANB SOCCER, INC., Released Parties, or otherwise, including, without limitation, the risks and inherent or unexpected dangers associated with training for, traveling to/from, competing in and otherwise participating in the sport of soccer. Participant further assumes full responsibility for any Injury resulting from any known or unknown medical or physical condition of Participant.			
3.	Release of ANB SOCCER, INC. duty to Protect Participant. PARTICIPANT EXPRESSLY RELEASES ANB Soccer, Inc. 4.	General Release, Waiver, Covenant Not to Sue. PARTICPANT EXPRESSLY AND FOREVER GENERALLY RELEASES, WAIVES, DISCHARGES, HOLDS HARMLESS AND COVENANTS NOT TO SUE: ANB Soccer, Inc., and all other individuals or entities associated with the Program including, without limitation, coaches, other participants, sponsors, advertisers, volunteers, rescue personnel, consultants, the premises or Program(s), and each of their respective directors, officers, members, coaches, managers, employees, agents, affiliates, volunteers and representatives (collectively "Released Parties"), FROM ANY AND ALL INJURY, LIABILITY, LOSS, DAMAGE, CLAIM OR DEMAND OF ANY KIND ARISING OUT OF OR RELATED TO THE PROGRAM OR PARTICIPANT'S PARTICIPATION IN THE SPORT OF SOCCER AT ANY TIME WHETHER CAUSED OR CONTRIBUTED TO BY THE NEGLIGENCE OR BREACH OF WARRANTY OF THE RELEASED PARTIES, PARTICIPANTS, THIRD PARTIES OR OTHERWISE ("Claims").
